REPORT ON THE ELECTIONS OF EXECUTIVE COMMITTEE / GOVERNING BODY OF THROWBALL FEDERATION OF INDIA

The election for the Executive Committee/ Governing Body of the Throwball Federation of India was conducted by the undersigned on 30th March 2025 at Kirat Resort, Aheri, Bhilai, Chhattisgarh.

I was appointed as the Returning Officer by the Federation. A copy of the Constitution of TFI, the Notice including the Agenda of the meeting, and the List of Voters (Electoral College) were duly provided to me.

In compliance with the Delhi High Court directions and various court cases and writ petitions, it is mandatory for all National Sports Federations to adhere to the National Sports Development Code, 2011 (NSDC 2011)—particularly in relation to election guidelines, age limits, and tenure restrictions for office bearers. Keeping these legal requirements in view, the election schedule was prepared in accordance with the NSDC 2011 and the Constitution of the Throwball Federation of India. This schedule was sent to all voters via email/ whatsapp and published on the Federation's website on 17th March 2025.

The election forms were designed by me as per the Model Election Guidelines of NSDC 2011 and were supplied to the voters accordingly. Nominations were invited for the following posts:

1. President (1)
2. Senior Vice President (1)
3. Vice Presidents (3)
4. Secretary General (1)
5. Joint Secretaries (4)
6. Treasurer (1)
7. Executive Members (11)

Nominations were to be submitted via email or in person before 25th March 2025 (4:00 PM). All candidates opted to submit their nominations via email with copies to their respective proposers and seconders. No objections were received from any proposer or seconder. The list of nominations received (Form II) was compiled into Form III and published on the Federation's website on the same day.

During the scrutiny of nomination papers, neither the candidates nor their representatives were present. The scrutiny was completed on 25th March 2025, and the list of valid nominations was published on Form IV, also on the same day.

It is important to note that one nomination for the General Secretary post was declared invalid during scrutiny. Additionally, two nomination forms were received after the deadline and were not considered during scrutiny as per the election guidelines.

As per the election schedule, Form 5 (Withdrawal Form) was invited from valid candidates by 27th March 2025. However, no withdrawal requests were received. A final list of candidates (Form 6) was then prepared and published on the Federation's website on 27th March 2025.

According to the final list:

- President : 01 nomination for 1 post (elected unopposed)
- Senior Vice President : 01 nomination for 1 post (elected unopposed)
- Vice Presidents : 03 nominations for 3 posts (elected unopposed)
- Secretary General : 01 valid nomination for 1 post (elected unopposed)
- Joint Secretaries : 05 nominations for 4 posts (**election required**)*
- Treasurer : 01 nomination for 1 post (elected unopposed)
- Executive Members : 11 nominations for 11 posts (elected unopposed)


As per the published election schedule, voting for the Joint Secretary post was conducted during the Annual General Meeting of TFI on 30th March 2025 at 10:00 AM.

At the meeting venue, a separate polling booth was established with a sealed ballot box, and ballot papers for the Joint Secretary post were prepared and distributed by me. A blind box was arranged to ensure secret voting, and each voter was provided with a separate pen to maintain uniformity and fairness; personal pens, pencils, or mobile phones were strictly not allowed inside the polling area. All candidates were permitted to remain inside the polling room to observe the entire election process. Before voting began, the empty ballot box was shown to all observers, after which it was sealed and placed on my table. The entire voting process was conducted under video recording to ensure transparency and accountability.

Voters were called in one by one, and their signatures were obtained on the attendance sheet before handing over the ballot papers, which bore my signature. A total of 30 voters cast their votes. After polling concluded, the ballot box was opened and the votes were counted in the presence of all candidates. All relevant documents were then sealed in three separate envelopes; each duly signed and stamped by me. The election results (Form XV), along with the vote count (Form 14), were handed over to the newly elected President, and the results were formally declared before the house.
